GOAL


To support the development, growth, and sustainability of child advocacy centers in Nebraska while promoting system improvements for abused and neglected children



Nebraska Alliance Budget

The Nebraska Alliance's overall approved budget for 2019 is \$493,415.00. Twenty-eight percent (28%) of our funding is redistributed around Nebraska as grants to the Nebraska CACs for services and for local training related to investigation, prosecution, treatment and prevention. Sixty-four percent (64%) provides training and technical assistance for our member center directors and staff and eight percent (8%) is for administrative costs of the Nebraska Alliance. 2019 Budget Distribution




